ELECTION OF OFFICERS

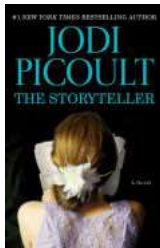

THE STORYTELLER by Jodi Picoult, Atria/Emily Bestler Books, 2013.



In this novel, Picoult explores the links between family, religion, humanity and difficult decisions. A young woman mourning the death of her mother meets an elderly man at a grief support group. Sage, whose Grandmother is a Holocaust survivor, eventually learns that her new friend is a Nazi officer who is ashamed of the horrible things he did during the war. He wants her to help him die. Is evil a forgivable sin?

FINDING HOLLIS by Pauline Knaeble Williams, Forty Press, 2014.



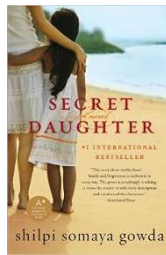
In 1944 North Minneapolis, Frances, a young white woman sees Hazel, a young black woman, get hit by a truck. As Hazel is dying, she asks Frances to "find Hollis." When Frances looks for Hollis, three separate worlds intersect, first by circumstance and then by understanding. A moving story of human frailty and resilience. A finalist in the Midwest Book Awards, Historical Fiction.

MAKING ROUNDS WITH OSCAR: The Extraordinary Gift of an Ordinary Cat by David Dosa M.D., Hachette Books, 2010.



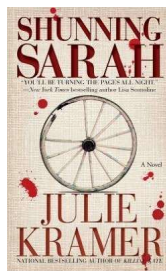
A true story about a cat's amazing ability to predict when death is near for the patients of a nursing home and to provide comfort to them in their final hours. As a skeptical Dr. Dosa talked to the patients' families about Oscar and listened to their touching stories, he gained a greater understanding of dementia, its impact on families, and the role of pets in our lives. A moving book about aging, death, and letting go.

SECRET DAUGHTER: A Novel by Shilpi Somaya Gowda, William Morrow, 2011.



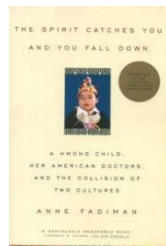
Kavita places her newborn daughter in a Mumbai orphanage to prevent her husband from disposing of a second “worthless” girl. Asha is adopted by a married couple from California, Somer (Caucasian, Protestant) and Krishnan (Indian, Hindu). The chapters alternate between Asha’s life as a member of a minority group in the US and Kavita’s hardships living in a slum in India. A novel about what it means to be a family.

SHUNNING SARAH: A Novel by Julie Kramer, Pocket Books, 2013.



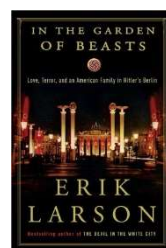
One in a series of mysteries featuring Minneapolis investigative TV reporter, Riley Spartz. When a young boy is trapped in a sinkhole in Harmony, MN, he discovers a dead body. Riley learns that the deceased was an 18 year old Amish girl, Sarah Yoder, who left the religion and was shunned by her family and her community. While looking into the murder, Riley also becomes involved with a local sheriff’s election, Sarah’s family, and the owner of an Amish handcrafts store. Lots of references to real locations in Minnesota.

THE SPIRIT CATCHES YOU AND YOU FALL DOWN by Anne Fadiman, Farrar Straus & Giroux, 2012.



Subtitled *A Hmong Child, Her American Doctors, and the Collision of Two Cultures*, this is an award-winning and heartbreaking account of what happened when a refugee couple from Laos brought their epileptic daughter to a California hospital. A powerful tale about the importance of practicing cross-cultural medicine in a world where there can be large gaps between healing methods, religious beliefs and social customs.

IN THE GARDEN OF BEASTS: Love, Terror and an American Family in Hitler’s Berlin by Erik Larson, Crown, 2011.



A vivid account of the experiences of newly appointed U.S. ambassador to Germany, William E. Dodd, and his family in Berlin in the early years of Hitler’s rule. Initially Dodd, a former history professor, hoped that Hitler would change and moderate Nazis would emerge. He eventually changed his mind as the social restrictions and acts of brutality under the Third Reich became impossible to ignore. Larson’s meticulous research of archival sources included Dodd’s diary.

SPECIAL QUESTIONS ON THE REGISTRATION FORM

You will see three special questions on the meeting registration form. Here's some additional information on them.

You can eat with others who use the same system that you use or you can sit with another group to learn about a different option.
2. Is your church available to host a future TCACLA meeting? One big advantage to this for you is that many of the planned keynote speakers will be of interest to a wider audience than librarians. For example, the speaker in April, 2016 will be Lindsay Hardin Freeman, an award winning author who has done extensive research on every woman who speaks in the Bible. If the meeting is held at your church, members of your congregation who are interested in this topic but aren't on the library committee might also be interested in hearing her speak. This could be a good promotional event for your library.
3. What is currently the most popular new book in your church library? This question comes from your editor. I'm always looking for suggestions for the *What Churches are Reading* feature. If more than one title comes to mind, include all of them!

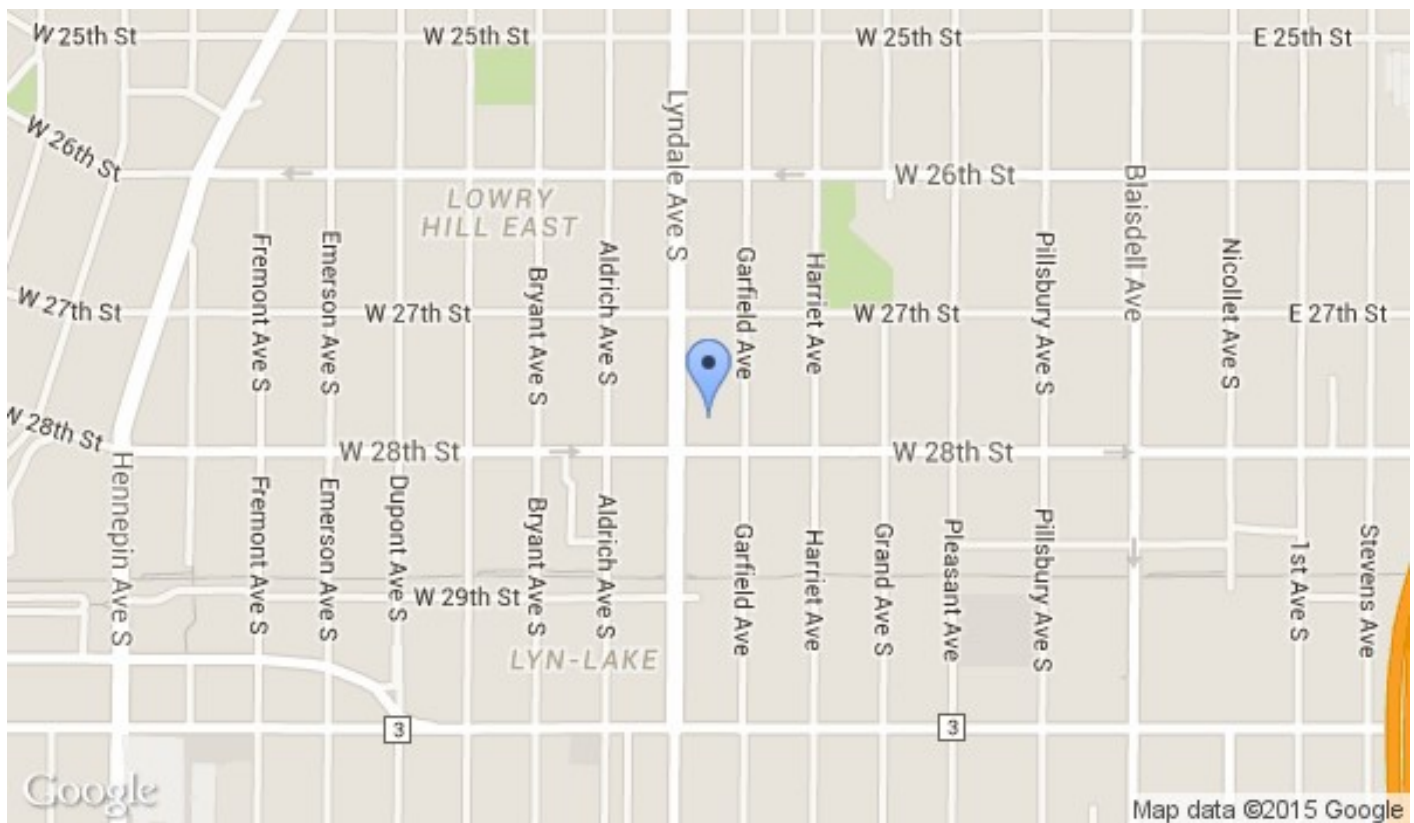

Driving Directions: SpringHouse is located between Lyndale and Garfield Avenues in south Minneapolis.

From the West and North: Follow I-94 East. Take exit 231A-B for Lyndale Ave/Hennepin Ave. Follow Lyndale Ave. Make a left at 28th Street. The center is located on the left hand side, just east of Lyndale on 28th Street.

From the East and North: Follow I-94 West. Take exit 231A-B for Lyndale Ave/I-394 toward Hennepin Ave. Take exit 231B on the left toward Hennepin Avenue/Lyndale Avenue. Follow Lyndale Ave. South. Make a left at 28th Street. The center is located on the left hand side, just east of Lyndale on 28th Street.

From the South: Follow I-35W North to I-94 West. Take exit 15 toward Lake St/31st St. Merge onto 2nd Ave S. Turn left at Lake St. Turn right at Lyndale Ave. Make a right at 28th Street. The center is located on the left hand side, just east of Lyndale on 28th Street.



Parking Information:

Limited parking spots, including handicapped spaces, are available in the Greenleaf lot between SpringHouse and the Greenleaf apartment building. Otherwise, you'll find lots of open spaces on Lyndale, 28th, Garfield, and other nearby streets.
